

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina situate, lying and being on the northern side of Hill Crest Drive and the western side of Berry Avenue and being known and designated as all of Lot No. 58 and part of Lot No. 59 on a plat of the Property of C. O. Berry recorded in the R. M. C. Office for Greenville County in Plat Book "M", at Page 29 and also designated as Lot No. 3 and part of Lot No. 2 of the Property of C. B.
