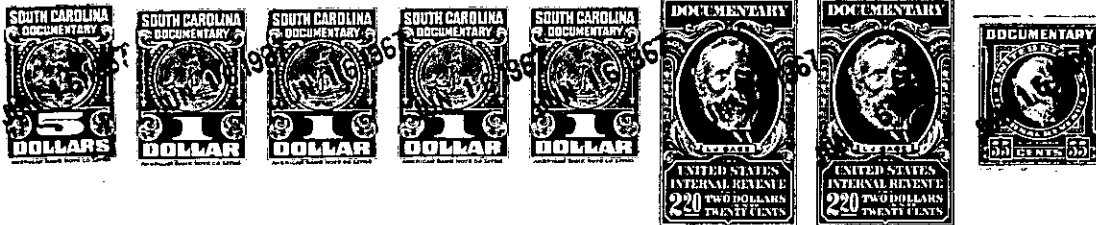
KNOW ALL MEN BY THESE PRESENTS, that ^{R.M.C.} CENTRAL REALTY CORPORATION
