WITNESSETH: That the said party of the first part, for and in consideration of the sum of One Thousand Two Hundred Forty Dollars (\$1,240.00) in hand paid by the said parties of the second part, the receipt of which is hereby acknowledged, has remised, released and quitclaimed, and by these presents does remise, release and quitclaim unto the parties of the second part, their heirs and assigns, forever, all the estate, right, title, lien, equity, interest, claim and demand which the said party of the first part has in and to that certain strip or parcel of land situate, lying and being at East Greenville, County of Greenville, State of South Carolina, and described as follows, to wit:
