All of that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, lying and being on the northeast side of Mary Street, shown and designated as Lot No. 67 on Map 1 of Camilla Park, said map being recorded in the RMC Office of Greenville County in Plat Book G at Page 225, and having, according to the said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Mary Street which iron pin is 204 feet in a northwesterly direction from the northeast intersection of Frances Avenue and Mary Street, at the joint front corner of Lots 66 and 67 and thence along the joint line of said lots, N. 67-54 E. 191.9 feet to an iron pin in the line of a twenty foot alley; thence along the southwest side of said alley N. 18-32 W. 67.95 feet to an iron pin in the joint rear corner of Lots 67 and 68; thence along the line of said lots S. 67-56 W. 194.6 feet to an iron pin in the line of Mary Street; thence along the northeast side of Mary Street S. 20-45 E. 68 feet to the point of beginning.
