ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and known and designated as Lot No. 28 on plat of Green Valley Subdivision prepared by Piedmont Engineering Company, and dated December 20, 1957, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at Pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern line of Green Valley Drive, joint front corner of Lots Nos. 28 and 29, and running thence with the joint line of said Lots N. 43-00 E. 329.1 feet to an iron pin in the edge of golf course, joint rear corner of Lots Nos. 28 and 29; thence along the edge of golf course S. 39-53 E. 190.3 feet to an iron pin, joint rear corner of Lots Nos. 28 and 27; thence running with the joint line of Lots 27 and 28 S. 41-21 W. 300.2 feet to an iron pin on the Northeastern line of Green Valley Drive, joint front corner of Lots Nos. 27 and 28; thence along the line of said Green Valley Drive N. 18-28 W. 200 feet to the point of beginning said Green Valley Drive N. 48-28 W. 200 feet to the point of beginning.
