BEGINNING at an iron pin at the western corner of Commercial Drive and Industrial Drive, and running thence with the northwestern side of Industrial Frive S. 38-06 W. 181.7 feet to iron pin in the center of a 20 foot alley, corner of property of Esso Oil Company; thence with the center of said alley and with the line of said Esso Oil Company, N. 51-54 W. 140 feet to iron pin; thence N. 38-07 E. 205.82 feet to iron pin on the southwestern side of Commercial Drive; thence with the southwestern side of said Drive, S. 52-15 E. 115 feet to iron pin at corner of Industrial Drive; thence with the curve of the intersection, the chord of which is S. 7-04 E. 35.2 feet to the beginning corner.

This lot is subject to an easement over the rear 10 feet for a 20 foot alley, as shown on said plat.
