the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thomas L. Colson and Fannie A. Colson, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 142 of a subdivision known as Colonial Hills, Section No. 3, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated May 7, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 91 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Ardmore Drive, joint front corner of Lots 142 and 143 and running thence with the joint line of said lots, S. 1-16 E. 160.9 feet to an iron pin; thence N. 86-50 W. 139.2 feet to an iron pin in the line of Lot 17; thence along the line of Lot 17 and continuing with the line of Lot 18, N. 9-45 E. 150.9 feet to an iron pin on the southern side of Ardmore Drive; thence with the southern side of Ardmore Drive, N. 87-41 E. 110 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
