the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto

Joseph B. Fitts, his heirs and assigns forever:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina situate, lying and being on the northern side of Confederate Circle and being known and designated as Lot No. 97, Section 3 of Sheffield Forest recorded in the R. M. C. Office for Greenville County in Plat Book "III", at Page 157 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Confederate Circle, joint front corner of Lots Nos. 97 and 98 and running thence with the common line of said lots N. 6-0 W. 177.6 feet to an iron pin; thence N. 69-15 E. 50.8 feet to a point on a creek; thence with the creek the line S. 61-26 E. 61.7 feet to an iron pin at the joint rear corner of Lots Nos. 96 and 97; thence with the common line of said lots S. 6-0 E. 155.5 feet to an iron pin on the northern side of Confederate Circle; thence with the northern side of said Circle S. 84-0 W. 100 feet to an iron pin, the point of beginning.
