KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County

in consideration of Fifteen Hundred and No/100 (\$1500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot 12 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Jacobs Road, joint front corner of Lots 11 and 12 and running thence along the joint line of said lots, N. 29-22 E. 132.5 feet to an iron pin in rear line of Lot 25; thence along the rear line of Lot 25 and continuing along the rear line of Lot 24, N. 60-38 W. 70 feet to an iron pin at rear corner of Lot 13; thence along the line of that lot, S. 29-22 W. 135 feet to an iron pin on the northeastern side of Jacobs Road; thence along the northeastern side of Jacobs Road, S. 62-51 E. 70.05 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665 at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record.
