the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James Cooley, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 22 of a subdivision known as Heathwilde as shown on a preliminary plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 139 and having, according to a plat of a portion of said subdivision prepared by Campbell and Clarkson, Surveyors, December 30, 1967, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Canterbury Road, joint front corner of Lots 21 and 22 and running thence along the eastern side of Canterbury Road, N. 11-27 E. 75 feet to an iron pin, N. 10-37 W. 50.2 to an iron pin, N. 5-44 E. 53 feet to an iron pin and N. 3-38 E. 50.3 feet to an iron pin at the corner of Lot 23; thence along the line of that lot, S. 79-16 E. 288.5 feet to an iron pin on the rear line of Lot 24; thence along the rear line of Lot 24 and continuing along the rear line of Lot 25, S. 18-47 W. 233.1 feet to an iron pin at a rear corner of Lot 21; thence along the line of that lot, N. 78-33 W. 245 feet to the point of beginning.
