warrant and forever defend the said premises to the said ROBERT N. & MINNIE A. CATER, THEIR  
heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to  
claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
