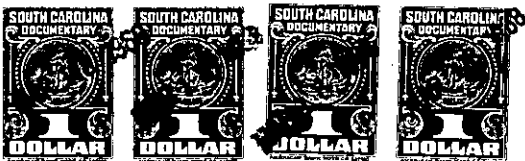
KNOW ALL MEN BY THESE PRESENTS, that I, DAVID I. HOROWITZ
