Know All Men by These Presents:

That we, Walter T. Holliday and Margaret H. Strickland, as Executor and Executrix, respectfully, of the Estate of Agnes M. Holliday, in the State aforesaid, in consideration of the sum of One (\$1.00) - - - - - DOLLARS, and partition of real estate.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Norden W. Davis and his heirs and assigns forever:

All those parcels or lots of land in Oneal Township of Greenville County, South Carolina, located about 2 1/2 miles north of the City of Greer, lying on the eastern side of Lee Circle, being shown on a plat designated as Section II of Holliday Hill, property of Agnes M. Holliday Estate, made by John A. Simmons, Registered Surveyor, on May 4, 1966, which plat was later amended, and having the following courses and distances, to-wit:

BEGINNING at an iron pin, the joint front corner of Lots Nos. 31 and 44 on the aforesaid amended plat and running thence with the common line of said lots, N. 30-41 W. 90.4 feet to an iron pin on the line of W. P. Gibson property; thence with the Gibson line, N. 75-40 E. 175 feet to an iron pin, on the line of the 1 acre tract conveyed to David Barry Sellers; thence with the Sellers' line and the rear lines of Lots Nos. 44 and 45, S. 44-33 E. 202.4 feet to an iron pin, the joint rear corner of Lots Nos. 45 and 46; thence with the common line of said lots, S. 59-19 W. 166.4 feet to an iron pin on the eastern side of said Circle, thence with the eastern side of said Circle, N. 30-41 W. 105 feet to an iron pin and N. 75-41 W. 70.7 feet to an iron pin, the point of beginning.

Last Will and Testament of the Late Agnes M. Holliday provided and directed that the Executors of her Estate sell all of her real estate and execute deeds therefore. The Executors have sold and conveyed a portion of the real estate, but as to the unsold remainder, the devisees and distributees under her Will have agreed to partition same among themselves and have instructed the Executors to execute deeds in accordance with their judgment as to a fair and proper distribution. This deed is made to carry out said purpose and plan.

The above mentioned plat is recorded in Plat Book 000, Page 199, R.M.C. Office for Greenville County.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
