in consideration of the sum of Eleven Thousand Nine Hundred (\$11,900.00) Dollars-----DOLLARS, same consideration as stated in deed of William Daly Bailey, et al to grantee to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Jones M. Blakely, his heirs and assigns forever:

All that certain lot of land lying in the State of South Carolina, County of Greenville, on the eastern side of Keith Drive (formerly known as Keith Street) shown as Lot 38 on a plat entitled "SUBDIVISION OF THE ED B. SMITH PROPERTY" recorded in the R.M.C. Office for Greenville County in Plat Book S at page 23 and being further described as follows:

BEGINNING at an iron pin on the eastern side of Keith Drive (formerly known as Keith Street) at the joint corner of Lots 38 and 39 and running thence along the line of Lot 39 N. 54-15 E. 150 feet to an iron pin; thence N. 35-45 W. 72.5 feet to an iron pin in the line of Lot 2; thence along the rear lines of Lots 2 and 1 S. 54-15 W. 150 feet to an iron pin on the eastern side of Keith Drive; thence along Keith Drive S. 35-45 E. 75 feet to the point of beginning. Being the same property conveyed to Kathleen Wilson by deed of Sam. W. Jones, dated August 4, 1956, recorded in Deed Book 558 at page 506.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
