All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 21 on plat of Mountain View Land Co., recorded in the RMC Office for Greenville County in Plat Book G at page 160, said lot having a frontage of 50 feet on the east side of Gridley Street, a depth of 125.5 feet on the north side, a depth of 136 feet on the south side, and a rear width of 52 feet.

This is the same lot conveyed to grantor and Mary M. Cox by Frank E. Estes by deed recorded June 3, 1959 in vol. 607 page 171 of the RMC Office for Greenville County, S. C. Mary M. Cox died intestate Sept. 1, 1966 leaving as her sole heirs and distributees at law the grantor herein and a son, W. D. Cox, the interest of W. D. Cox having been conveyed to the grantor by deed dated October 2, 1968.
