KNOW ALL MEN BY THESE PRESENTS, that I, Martha G. Meeks,

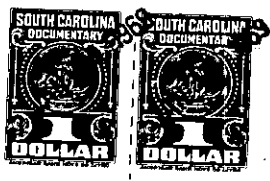
in consideration of One Thousand (\$1,000.00) Dollars-----Dollars,
