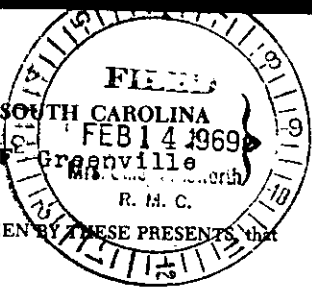

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore,

in consideration of - - Five Hundred Ninety-five and No/100 (\$595.00) - - - - - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Mrs. Frances V. Hardrick, her heirs and assigns, forever:

ALL that lot of land in Chick Springs Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 9 Holtzclaw Road, of Holtzclaw Estates, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG, Page 147 and more fully described, to-wit:

BEGINNING on Holtzclaw Road at an iron pin at joint front corners of Lots 8 and 9 and running thence 100 feet with the line of said Road to an iron pin at joint front corners of lots 9 and 10; running thence 225 feet with the side line of lot 10 to an iron pin at joint rear corners of lots 9, 10 and 18; running thence 100 feet with the rear lines of lots 18 and 19 to an iron pin at joint rear corners of lots 8, 9 and 19; running thence 225.0 feet with the side line of Lot 8 to the iron pin at joint front corners of lots 8 and 9 on Holtzclaw Road, the point of beginning.

ALL lots to be used for residential purposes only, except lots No. 1, 2, 3, 4, 47, 48, 49, 50 and 51; No building costing less than \$7,500.00 shall be erected on any lot. No building shall be erected on any lot nearer than 30 feet to the front line; No lots shall be subdivided. No outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for the year 1969.
