to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto HENRY P. WILLIMON, JR., AND BETTY JANE WILLIMON, their heirs and assigns forever, an undivided one-half (1/2) interest of, in and to:

ALL that piece, parcel or lot of land in Greenville Township, State and County aforesaid, and in the City of Greenville, fronting sixty six (66) feet on Laurens Street, one hundred (100) feet on Coffee Street, one hundred twenty (120) feet on Buncombe Street and one hundred thirty five (135) feet on back line from Buncombe to Coffee Street. Said property being that on which the Virginia Hotel now stands and being the same conveyed to Henry P. Willimon by deeds of Lula R. McBee as Executrix and Oscar Hodges as Trustee, dated January 10, 1947, and recorded in Deed Book 305 at Page 324 and Annie McBee Moore by deed dated June 18, 1946, and recorded in Deed Book 294 at Page 244. Together with all right, title and interest of the Grantor as Trustee in all furniture, fixtures and other personal property of every kind and nature now situated in or on said premises.

By deed dated June 30, 1955, Henry P. Willimon conveyed all his right, title and interest, the same being an undivided one-half interest, in the premises herein described to the First National Bank, of Greenville, S.C. as Trustee under Agreement with Henry P. Willimon dated June 30, 1955. Said deed is recorded in the R.M.C. Office for Greenville County in Deed Book 529, Page 412. The Grantor herein is the Successor Trustee under said Agreement by virtue of its consolidation with with the First National Bank of Greenville, S.C.

The Grantees herein are the same persons named in the aforementioned Trust Agreement, and the youngest of them having reached the age of twenty-one(21) years, distribution of the property herein conveyed is being made to them by the Grantor in accordance with the provisions of said Trust Agreement dated June 30, 1955.
