(11) To take possession, and order the removal and shipment of any perty from any post, warehouse, depot, dock, or other place of storage or safekeeping, governmental or private; and to execute and deliver any release voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose.
