All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, near the Corporate Limits of the City of Greer and South therefrom, lying on the southeast side of Wolfe Road, being shown on a plat made for R. B. Taylor, et al, by Terry T. Dill, Surveyor, dated November 30, 1967, and having the following courses and distances:
