the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Olive P. Youngblood, her heirs and assigns, forever,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, City of Greenville, State of South Carolina, on the northwestern corner of Wilton Street and Randall Street and being known and designated as part of Lot No. 22, Section A, on plat of Stone Land Company, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book "A", at pages 337 and 345 and having, according to a more recent survey dated September 17, 1964, by R. K. Campbell, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern intersection of Wilton Street and Randall Street and running thence along the northern side of Randall Street n. 83-36 w. 108.75 feet to an iron pin; thence across the rear line of Lot No. 22 n. 2-10 e. 69.5 feet to an iron pin; thence s. 81-19 e. 108.79 feet to an iron pin on the western side of Wilton Street; thence with said Street s. 2-04 w. 65 feet to an iron pin, the point of beginning.
