the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release School District of Greenville County, its successors or assigns, forever:

ALL that certain piece, parcel or tract of land containing 34.54 acres, less, and located in Chick Springs Township, Greenville County, South Carolina, near the corporate limits of Greer, and according to a recent survey by John A. Simmons, Registered Surveyor, having the following metes and bounds, to-wit:

BEGINNING at an old nail in the center of Bright Road at joint corner of property of Nathan Earl Bright, deceased, and George T. Dill, and running thence with the center of said road the following courses and distances: S. 57-19 W., 100 feet; S. 48-25 W., 100.2 feet; S. 49-53 W., 346 feet to an old nail in the center of Bright Road; thence leaving Bright Road and running with the line of F. G. Ballenger Property S. 11-30 W. 457 4 feet to an old iron pic. thence center of Bright Road; thence leaving Bright Road and running with the line of E. G. Ballenger Property, S. 11-39 W., 457.4 feet to an old iron pin; thence S. 0-58 W., 100.8 feet to a new iron pin; thence continuing with property of E. G. Ballenger, S. 61-69 E., 792.3 feet to an old iron pin; thence S. 37-03 W., 409.2 feet to an old iron pin in the line of property of W. Don Owens, et al.; thence with the line of W.
