ALL of that lot of land in the County of Greenville, State of South Carolina, in Chick Springs Township, on the southeastern side of Kimberly Drive, a short distance south of the intersection of State Park Road, Highway 253, as shown on plat of E. P. Gravitt made by Carolina Engineering and Surveying Co., dated November 19, 1969, and recorded in the R. M. C. Office for Greenville County in Plat Book CCCC, page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Kimberly Drive at the corner of property this day being conveyed to Edith B. Littleton, which iron pin is situate 600.6 feet south of the center of S. C. Highway 253, referred to as State Park Road, and running thence S 85-56 E 169.5 feet to the old dividing line between the Holcombe Tract and the Turner Tract, and running thence along the old line, now the line of Wallace B. James, S 3-05 W 248.5 feet to an iron pin at the corner of Rainey; thence N 63-57 W 112.3 feet to an iron pin on the eastern side of Kimberly Drive; thence N 22-0 W 112.5 feet to an iron pin; thence N 20-50 W 70.5 feet to an iron pin; thence continuing along said Drive N 11-13 E 42 feet to the point of beginning and being a portion of the property conveyed to us in Deed Book 305, page 12, and Deed Book 738, page 524. This property is subject to all rights-of-way and restrictions of record.
