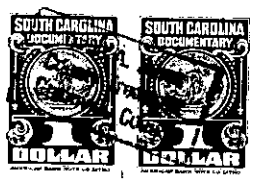
KNOW ALL MEN BY THESE PRESENTS, that Fred T. Whitfield and Selena M. Whitfield -----
