J. ROY STONE, his heirs and assigns forever:

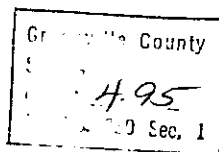
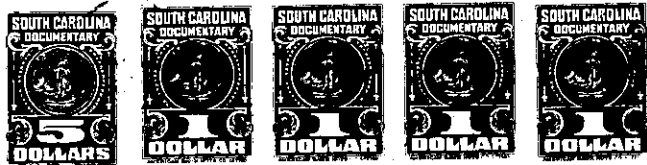
