

(a) the Trust is subject to termination pursuant to the provisions of Article 10; and

(b) in the event Section 52-203 of the Code of Laws of South Carolina, or any other statute or rule of law of like intent and purpose which may hereafter become applicable to the Trust shall provide that the Trust may not continue perpetually, then the Trust shall continue for the longest period of time permitted by law, unless sooner terminated as provided in Article 10, and to the extent that measuring lives in being are required to determine the term of the Trust, such measuring lives in being shall be the following persons living at the time of execution of this Declaration, and the Trust shall in such event, unless sooner terminated as provided herein, continue until the death of the last survivor of them plus such maximum additional period of years as is permitted by law:






