KNOW ALL MEN BY THESE PRESENTS, that I, PHYLLIS S. METZ

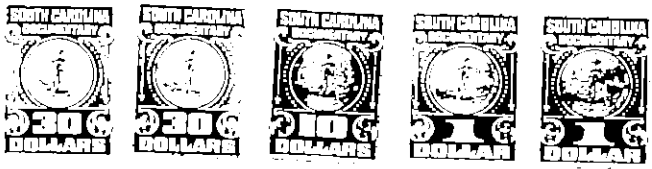
in consideration of THIRTY-SIX THOUSAND AND NO/100 (\$36,000.00)-----Dollars,
