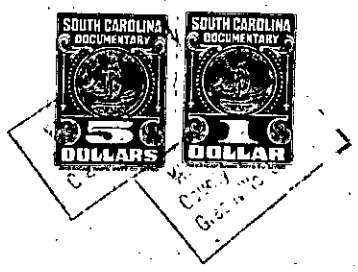
An undivided one-third (1/3) interest in and to all that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Chippendale Court near the City of Greenville, S. C., being known and designated as Lot No. 67 on plat entitled "Final Plat Revised, Map # 1, Foxcroft, Section II" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37 and, having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Chippendale Court, said pin being the joint front corner of Lots 67 and 68 and running thence with the common line of said lots S 68-36 W 194.8 feet to an iron pin; the joint rear corner of Lots 67 and 68; thence N 45-00 E 107 feet to an iron pin; thence N 45-10 E 237 feet to an iron pin, the joint corner of Lots 66 and 67; thence with the common line of said Lots S 42-36 E 153.3 feet to an iron pin on the westerly side of Chippendale Court; thence with the westerly side of Chippendale Court on a curve, the chord of which is S 15-56 W 60 feet to an iron pin, the point of beginning.
