ALL water lines, mains, valves and appurtenancss installed and located in, under or along Airport Rd., Williamson Rd., Haywood Rd., and McKissick Dr., County of Greenville, State of South Carolina, including approximately 2,130' more or less of 8" pipe; 3 - 8" valves, 1 - 6" valve; 1 - 2" valve; and 1 Fire Hydrant, and is shown on a drawing labled, "A.F. McKissick & Walter W. Goldsmith, Trustees to City of Greenville," attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
