All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Ladbroke Road, near the City of Greenville, S. C., being known and designated as Lot No. 351 on plat of Del Norte Estates, Section III, Sheet No. I as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4N, pages 14 and 15 and having, according to said plat the following metes and bounds, to-wit:
