APPLIED INVESTMENT & DEVELOPMENT, INC., ITS SUCCESSORS AND ASSIGNS, FOREVER:

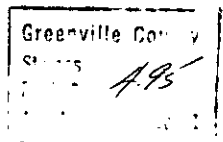
