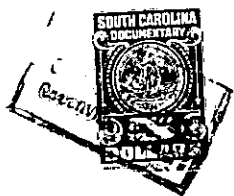
in consideration of Two Thousand Five Hundred & no/100ths (\$2,500.00)-----Dollars,
