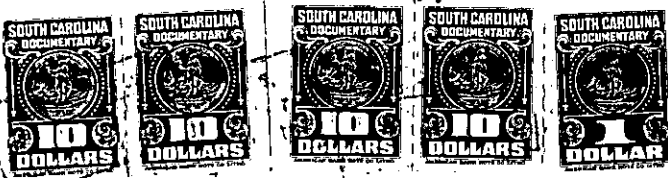
in consideration of Twenty Thousand Five Hundred and No/100-----(\$20,500.00)----- Dollars,
