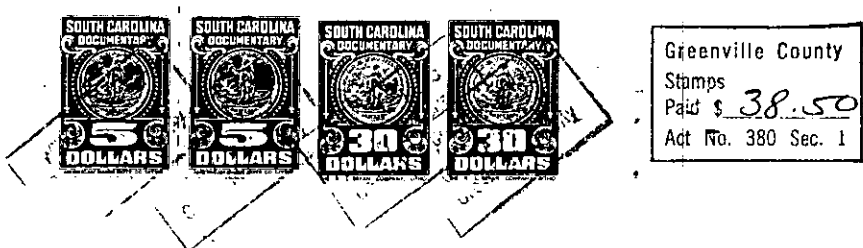
KNOW ALL MEN BY THESE PRESENTS, that **ALBERT S. HAGOOD**

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Fernwood Lane in the city of Greenville, being known as Lot No. 54 and a portion of Lot No. 53 as shown on a plat of CLEVELAND FOREST recorded in the R.M.C. Office in Plat Book M, at page 57, and also being shown on a revised plat of the Property of Elizabeth W. and R. E. Houston, Jr., recorded in Plat Book LL, at page 87, and described as follows:
