 to said plat being craved for a complete and detailed description thereof.

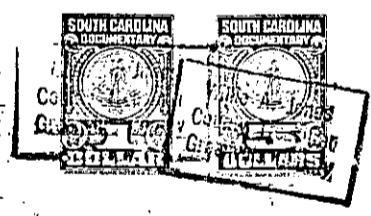
