(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents  
do grant, bargain, sell and release unto the said Delphia Greene

All our right, title, and interest in and to:

ALL that certain piece, parcel or lot of land situate, lying  
and being near the Western side of Urban Street (formerly Palmetto  
Street) being known and designated as the rear portions of Lots Nos. 52,  
53 and 54 as shown on plat entitled "Property of West End Land & Improve-  
ment Company", recorded in the R. M. C. Office for Greenville County,  
South Carolina, in Plat Book A at page 153 on April 11, 1907, and having  
the following metes and bounds:

BEGINNING at an iron pin at the joint rear corner of Lots Nos.  
34, 35 and 55 and running thence with the line of Lot No. 55 N. 79 E.  
52 feet to an iron pin in the line of Lot No. 55; thence with a new line
