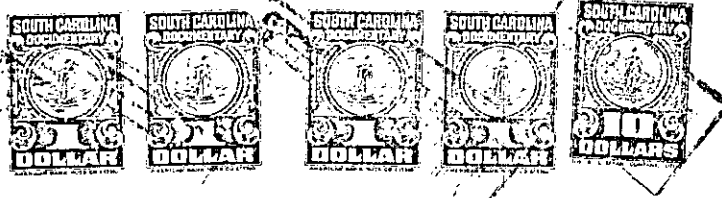

the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents  
do grant, bargain, sell and release unto the said N. Q. Cline, Sr., his heirs and assigns,  
forever:

All that piece, parcel or lot of land on the southeastern side of Viola Street (formerly known as Parker Street) in the County of Greenville, State of South Carolina being shown as Lot No. 14 of Block 3, Sheet 11 on the Greenville County Tax Maps and being further described as follows:

BEGINNING at a point on the southeastern side of Viola Street at the joint front corner of Lots 13 and 14 and running thence with Lot 13 in a southeasterly direction 51 feet more or less to an iron pin at the joint rear corner of Lots 14 and 16; thence with Lot 16 in a southwesterly direction 36 feet to an iron pin at the joint rear corner of Lots 14 and 15; thence with Lot 15 in a northwesterly direction 51 feet to an iron pin on Viola Street; thence with said Street in a northeasterly direction 36 feet to the point of beginning. — 500-11-3-14

Also, all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina on the southeastern side of Viola Street (formerly known as Parker Street) being shown as Lot 13, Block 3, Sheet 11, on the City Block Book, and being more particularly described as follows:

BEGINNING at an iron pin in the southeastern side of Viola Street, at corner of Lots now or formerly owned by Gilliard and running thence with line of said property, now or formerly of Cordell, in a southeasterly direction 116 feet to an iron pin, corner of property now or formerly of Burty; thence with line of property now or formerly of Burty and Nabers, in a northeasterly direction 50 feet to an iron pin, corner of property now or formerly of Harris; thence with line of said property, in a northwesterly direction 116 feet to an iron pin in southeast side of Viola Street; thence with said Street, in a southwesterly direction 50 feet to the point of beginning. — 500-11-3-13

Also, all that piece, parcel or lot of land situate on the southeastern side of Viola Street (formerly known as Parker Street) in the County of Greenville, State of South Carolina, being known as Lot No. 12, Block 3, Sheet 11 on the Greenville County Tax Maps and being described as follows:

BEGINNING at a point on Viola Street, corner of a 20-foot alley and running thence with said 20-foot alley in a southeasterly direction 116 feet to a point in the line of property now or formerly belonging to Lidie Williams; thence with her line in a southwestern direction 46 feet and 2 inches; thence in a northwestern direction parallel with the first line mentioned above 116 feet to Viola Street; thence with Viola Street in a northeastern direction 46 feet and 2 inches to the beginning corner.
