in consideration of Five and 00/100 (\$5.00) ----- Dollars,  
and correction of deed,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Alfred Wayne Cash, his heirs and assigns forever,

ALL that certain piece, parcel or lot of land situate, lying and being in  
the State of South Carolina, County of Greenville, Grove Township, on the western side  
of U. S. Highway No. 25, below the settlement known as Moonville, and having the fol-  
lowing metes and bounds, to-wit:

BEGINNING at an iron pin, joint corner of Alfred Wayne Cash and running thence  
along U. S. Highway No. 25 S. 7-35 W. 120 feet, joint corner of Grantor and running thence  
along line of Daisy B. Cash N. 80-10 W. 285 feet to an iron pin; thence along line of  
Grantee, Alfred Wayne Cash, N. 7-45 E. 130.8 feet to an iron pin; thence still along line  
of Alfred Wayne Cash S. 80-10 E. 285 feet to an iron pin, the point of beginning..
