ALL that piece, parcel or lot of land situate, lying and being on the south-western side of the Enoree River near the mouth of Brushy Creek and lying to the east of Brushy Creek Road and to the northwest of S. C. 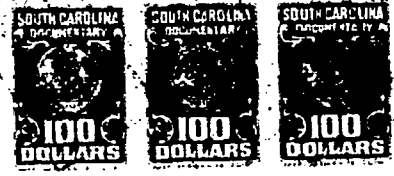
