
In consideration of Ten Dollars and other valuable considerations, Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Polly S. Baugheeme, her Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and
being in the State and County aforesaid, Chick Springs Township,
about one mile west of Pleasant Grove Baptist Church, lying on the
South side of the Gibbs Shoals Road, being bounded on the north by
the said road, on the east by lands, now or formerly of Oles Hiett,
on the south by lands of Clarence Nichols, and on the west by lot,
now or formerly of Marshall Johnson, and being the same lot conveyed
to me by deed recorded in the office of the R. M. C. for Greenville
County in Deed Book 961 at page 469, and having the following courses
and distances, to wit:-

Beginning on a nail and cap in the center of the said Gibbs Shoals
Road, joint corner of the lot, now or formerly of Oles Hiett, and

with the same course for a total distance of 336.7 feet to an
iron pin on the Nichols line; thence with the common line of Nichols
and this lot, N. 37-13 E. 210 feet to an old iron pin, the Oles Hiett
corner; thence with the common line of the Hiett lot, and of this lot,
N. 30-17 W. 296 feet to the beginning corner, containing One and Fifty-
