these presents do grant, bargain, sell and release unto the said George H. Tucker, his heirs and assigns forever, all my right, title, and interest, in and to the below described property, same being an undivided two-thirds interest, to wit:

All that certain piece, parcel, or tract of land, situate, lying, and being in the State of South Carolina, County of Greenville, Township of Butler, shown and designated as tract No. 1 containing 6.93 acres, more or less, on a plat of same prepared by Curtis M. Applewhite, S.C. Reg. L.S. No. 4194, under date of March 30, 1979, said plat being duly of record in the Office of the Clerk of Court for the County of Greenville, State of South Carolina, in Plat Book 7-6 at Page 57, the metes, bounds, courses, and distances as are shown on said plat being incorporated herein by reference and made a part of this description hereof. As shown on said plat, tract No. 1 herein conveyed is triangular in shape, and is bounded on the North by land of Velma W. Goldman (now land of C. K. Watson); on the East by a paved county road; and on the West by lands now or formerly of Ralph O. McCall, reference invited to deed book 249 at page 222.

The property herein conveyed is a portion of lands of which Mrs. Nellie Lee Watson Tucker Adams died seized and possessed and which she devised by her aforementioned will to the grantors and the grantee herein as tenants in common and which they have orally effected a partition and division with the above described tract No. 1 being allotted to the grantee herein and in which said grantee has excepted and confirmed this oral partition in kind by his acceptance of this deed and by joining in cross conveyances with the other grantors this date.
