ALL that piece, parcel or tract of land, located, lying and being in the County of Greenville, State of South Carolina, containing 7.72 acres, more or less, as shown on survey entitled "Property of J. L. and Carol C. Lafoy, et al", prepared by C. O. Riddle, R.L.S., dated March 29, 1979, and having, according to said plat, the following metes and bounds, to-wit: 576.1-1-10.3

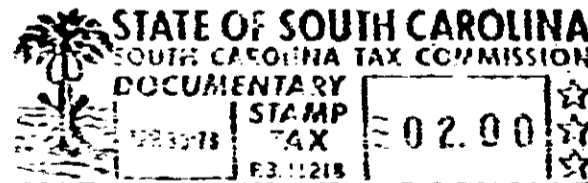
