BEGINNING at an iron pin on the north side of Westridge Court (which iron pin is 241.7 feet in a westerly direction from the intersection of Westridge Court and Westridge Road) thence N. 68-26 W., 100.1 feet to an iron pin; thence N. 73-54 W., 133.1 feet to an iron pin; thence N. 7-46 E., 312.1 feet to an iron pin; thence N. 83-30 E., 171.6 feet to an iron pin; thence S. 2-22 E., 368.9 feet to an iron pin being the point of beginning.

  3. Single wide mobile home not allowed. Double wide allowed on permanent brick or block foundation, 24 inches minimum ground clearance at lowest point required. Minimum double wide trailer size 24' x 55'.
  4. Temporary single wide mobile home allowed during construction of house. This mobile home can only be set-up after foundation for permanent house is constructed. A maximum of one year is allowed for the temporary mobile home. GRANTOR TO PAY 1979 GREENVILLE COUNTY TAXES.
