Lessee and the County will fully cooperate with the Lessee in any effort by the Lessee to avail itself of any such investment tax credit and depreciation charge.

SECTION 6.4. Insurance Required. Throughout the Lease Term, the Lessee shall keep the Project continuously insured as hereinafter provided, paying (except as provided in Section 4.3 hereof) as the same become due all premiums in respect thereto. Such insurance shall include but not necessarily be limited to:

- (a) Insurance upon the repair or replacement basis if available, and otherwise to the full insurable cash value of the Project as determined by an insurer selected by the Lessee or as otherwise agreed to by the County and Lessee, against loss or damage by fire and lightning, with uniform standard extended coverage endorsement limited only as may be provided in the standard form of extended coverage endorsement at the time in use in South Carolina; provided that the insurance required by this subsection may contain a deductible provision of not in excess of \$25,000 direct damage applicable to each separate instance of loss or damage insured against.
- (b) Boiler and pressure vessel (including pressure pipes) explosion insurance in an amount at least equal to \$2,500,000 (with deductible provisions not to exceed \$75,000 with respect to all boilers and pressure vessels and pressure pipes installed in the Project.
- (c) General public liability insurance against claims for bodily injury, death or property damage occurring on, in or about the Project and the adjoining streets, sidewalks, and passageways, such insurance to afford protection of not less than \$1,000,000 per occurrence with respect to bodily injury or property damage, provided that the Lessee shall have the option to self insure in an amount to be determined by the Lessee. Such self insurance may, at the Lessee's option, be taken directly as a deductible or indirectly under any type of retrospective rating arrangement between the Lessee and such insurer as it may select.
- (d) Insurance (or authorization by the appropriate officials of the State of South Carolina to self insure) covering any liability under the Workmen's Compensation laws of South Carolina for deaths of or injuries to persons arising out of any act during the Lease Term.

SECTION 6.5. Application of Net Proceeds of Insurance. The Net Proceeds of the insurance carried pursuant to the provisions of Section 6.4 hereof shall be applied as follows:
