BEGINNING at an old iron pin at the end of a dirt drive which connects the 4 acres to Barker Road, and running thence N. 48-55 E. 561.5 feet to a point; thence continuing to the center of a branch as the line; thence with center of said branch as the property line following the meanders thereof in a southeasterly direction, the chords of which are as follows: S. 48-25 E. 160 feet, S. 20-42 E. 80.4 feet, S. 24 E. 65 feet and S. 18-35 W. 64 feet; thence leaving the branch and running S. 51-40 W. approximately 499 feet to a point; thence N. 30-45 W. 145 feet to an old iron pin; thence N. 41-41 W. 159.1 feet to an old iron pin at the end of a 40-foot dirt drive that connects the property with Barker Road.
