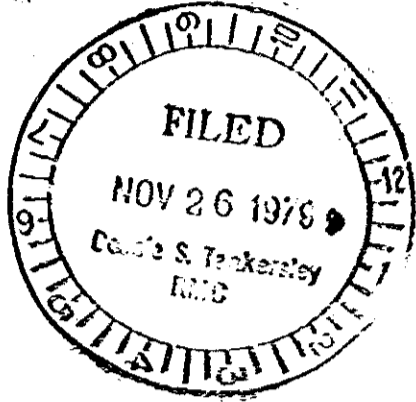

BEGINNING at an iron pin on the northern side of North Beaver Lane at the

of Lot No. 235; thence along the line of Lot No. 235, N. 83-04 W. 56.9 feet  
to an iron pin at the rear corner of Lot No. 234; thence along the line of  
Lot No. 234, S. 48-59 W. 120.1 feet to an iron pin on the northern side of  
North Beaver Lane; thence along the northern side of North Beaver Lane in
