CONTRACT FOR DEED COUNTY OF GREENVILLE THIS AGREEMENT made and entered into this 21 day of November 1979, by and between Hugh Drake of Greenville County, Sc of Greenville County, South Carolina, hereinafter called Saller, and James Pulley and Frances Pulley hereinafter called Buyer.
