## WITNESSETH

For and in consideration of the mutual covenants herein expressed and the further consideration of One Dollar (\$1.00) by the Purchaser to the Sellers paid, receipt of which is hereby acknowledged, the Sellers agree to sell and the Purchaser agrees to purchase all that land described as follows:

BEGINNING at an iron pin at joint corner of Lots 1 and 2, said pin being 15 feet from the pipe line as shown on the said plat, and running thence N. 46-5 E. 33 feet to a point; thence through the center of Lot No. 2, S. 23 E 26.3 chains, more or less, to a point in the middle of Saluda River; thence with the River as the line in a southwesterly direction 33 feet to a point, joint corner Lots 1 and 2; thence along the joint line of Lots 1 and 2, W. 23W. 2177 chains to an iron pin, the point of beginning and containing .135 acres, more or less, as shown on the said plat.
