KNOW ALL MEN BY THESE PRESENTS, that Greenville County, a body politic and corporate and a political subdivision of the State of South Carolina, acting by and through the County Council of Greenville County, in consideration of the sum of One Dollar (\$1.00) to it in hand paid at and before the sealing of these presents, the receipt of which is hereby acknowledged, has pledged, assigned, transferred and set over unto The Citizens and Southern National Bank of South Carolina, and its successors and assigns, all of the right, title and interest of said Greenville County in

and to the foregoing Lease Agreement dated as of 12/1/79 between said Greenville County, as Lessor, and Swiss-tex, Incorporated, as Lessee, including, without limitation, the right to receive Lease Rentals pursuant to the Lease Agreement (except its rights to receive payments pursuant to Section 5.5, 6.2, 8.7 and 10.4 of said Lease Agreement).

The parties agree that the pledge and assignment made hereby shall not subject the Bank to, or transfer or pass, or in any way affect or modify, any obligations of the County under the Lease Agreement, it being understood and agreed that all such obligations of the County shall be and remain enforceable only against the County.

IN WITNESS WHEREOF, Greenville County, South Carolina, has executed this Assignment by causing its name subscribed by the Chairman of Greenville County Council and the County Administrator of Greenville County and the official seal of said County to be impressed hereon, all being done as of the 27th day of December, 1979.
