Charles W. Murphy and Marguerite B. Murphy, their heirs and assigns:

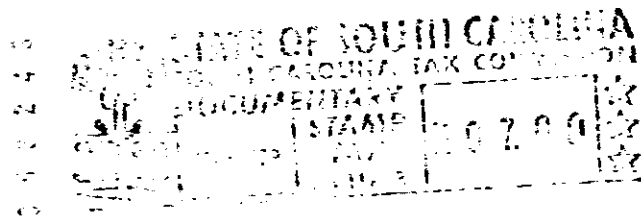
